

# OFFICIAL CONTEST RULES – WIN A TRIP TO SEE ARIANA GRANDE IN LOS ANGELES

## SPONSOR / OWNER / PARTICIPATING STATIONS

This contest is conducted by radio stations **KCDU (Monterey, CA), KZBD (Spokane, WA), KWLZ (Redding, CA), and KHTN (Merced, CA)** (collectively, the “Participating Stations”), which are owned and operated by **Stephens Family Limited Partnership, owner of Stephens Media Group radio stations** (the “Sponsor”).

## ELIGIBILITY

Limit **one (1) entry per person per keyword**. Duplicate, automated, or bulk entries may be disqualified at Sponsor’s sole discretion.
